Instructions for the submission of abstracts to the final conference of COST E53 in Edinburgh, May 2010

These instructions have been prepared in the format required for abstracts for the COST E53 conference in Edinburgh.

The abstract should be at least 200 words, but must not exceed 400 words. It should be a concise, stand-alone, summary of your paper in UK English without any references, figures, tables and equations. Any quantities given should be SI units leaving a space between the number and the unit.

Page margins should be 3 cm on all sides. The abstract text should be 12 point Arial font with single spaced lines justified to the left and right margins. Paragraphs should be separated by a 12 point spacing (equivalent to the height of one line).

The title of the paper should be written in 14 point Arial bold and centred at the top of the page. It should span no more than two lines and be followed by a 14 point spacing. The author's names should be written in 12 point Arial italic and centred below the title. Family names should be written in full after the initials of given names (each followed by a full stop). The last two authors names are to be separated by an ampersand (&), and other authors names by a comma. All author names are to be marked with a superscript number to identify affiliations and contact information, which should be provided in footnotes. The footnotes should be 12 point Arial, left aligned, and single spaced. For each author the position and email address (not as a hyperlink) should be written on the first line, and the affiliation and country should be written on the second.

Abstracts should be submitted as unprotected Word files or pdf by 6th January 2010 by email to coste53@napier.ac.uk together with a completed copy of the form on the following page. The members of the COST E53 technical committee will review the abstracts and the authors will be informed about acceptance of their paper for presentation at the conference by 18th January 2010. Papers are accepted on the basis that they match conference themes and the international standards of scientific writing. The authors are responsible for the correctness of the scientific content.
